AF Space Command—Commander's Breakfast

It is not every day a US Air Force 4-Star General visits our Chapter, but one just did. On 25 June 2015, General John Hyten, USAF, Commander of Air Force Space Command, spoke at a breakfast sponsored by the Tennessee Valley Air Force Association at Redstone Federal Credit Union on 220 Wynn Drive in Huntsville. Over 30 Chapter Members and Representatives of the Chapter's Community Partners were in attendance. Members enjoyed a breakfast of pastries, fruit, yogurt, coffee/tea, juice and water. After an Invocation delivered by Chapter Member Al Kemmet, Chapter President Rick Driesbach provided an official welcome and also lead those in attendance in the Pledge of Allegiance. After breakfast concluded, Chapter member Burke Hare introduced General Hyten.

General Hyten, a native of Huntsville, focused his remarks on the development of Aerospace Power within the United States Air Force. Of Particular note, General Hyten discussed how Space and Cyber Systems are central to every combat operation conducted by US and Allied Forces in the 21st Century. General Hyten emphasized the United States is very dependent on space assets and without these assets, the US would have to fight as we did over 40 years ago. As a follow-up to this point, the General spent time outlining the need to protect Space and Cyber assets to include emphasis on Space as no longer a sanctuary. Air Force assets must be protected and it is the job of Air Force Space Command to do just that. The General concluded by taking questions from the audience for several minutes.

In thanks to the General for his time and remarks to the Chapter, Chapter member Scott Patton presented General Hyten a check to be used as a donation to the Wounded Airman Program in the General's name. Chapter member Burke Hare followed up by presenting General Hyten with the official Chapter challenge coin.

This summer at the Jackson Center (a Community Partner), the Chapter hosted the 2015 AFA South-Central Region and Alabama State AFA Conventions. AFA members from across the state, as well as, from Arkansas, Louisiana, Mississippi, and Tennessee attended. AFA National was also present, with David Dietsch, Vice Chairman for Field Operations, Tom Gwaltney, National Director Central Area, and Kari Hahn, Vice President for Membership and Field Relations all there, providing policy and updates on activities across AFA. Breaking away from the traditional chapter reporting, the group addressed some of the challenges facing chapters today. Issues, such as declining membership and the need to instill interest by more members to serve as chapter leaders, were the focus of a lengthy discussion. David Dietsch continued the discussions in his National update, highlighting some of the new initiatives that are being considered at the National level.

Greg Ennis, Alabama AFA State Teacher of the Year and a James Clemens HS teacher, spoke about his recent AFAsponsored STEM teacher trip to Joint-Base Lewis-McChord and the Seattle area. Forty teachers from all over the southeast and the Seattle area participated in the event. The trip included visits to several aviation museums to honor the 70th Anniversary of the end of WWII and to further AFA's Museum Initiative. The group also visited the Boeing-Everett facility where the KC-46A Pegasus and 787 Dreamliner are being built for future aviation endeavors. Other exciting additions to the trip included flying in a military airlift aircraft, getting a briefing at the Western Air Defense Sector at McChord AFB, touring the Headquarters of Starbucks and Microsoft, flying in a seaplane over Seattle, along with visits to other notable tourist attractions in the area.

Ms. Rebekah Linton, Silver Wings Region V President, was also a guest speaker at this year's convention. She provided insight into Arnold Air Society and Silver Wings and discussed their recent, highly successful National Conclave that took place in Chicago earlier this year. This year's Joint Project is "The Spirit of 45" – honoring the 70th

Tennessee Valley Chapter Recognizes Two Outstanding Teachers

Our Tennessee Valley Chapter has long recognized that our youth are our future and for that reason we have a very active aerospace education program. A key component of this program is recognizing Teachers of the Year. In its selection, the Chapter reaches out across the Tennessee Valley to find teachers who inspire young people in the areas of science, technology, engineering, and math (STEM). It is not surprising that in a town known as the Rocket City, which neighbors with another city where rockets are built, STEM is a major focus in our community.

At the elementary level, Ms. Kim VanHooser from Central School in Huntsville is this year's Teacher of the Year. A gifted education teacher, Kim teaches 5th grade, specializing in math, science, and engineering. One way she inspires her students is with a yearly field trip to Dauphin Island. While there, the students participate in the Dauphin Island Sea Lab's nationally recognized programs concerning marine environments. During the three-day trip, the students are immersed in STEM activities, such as trawling in Mobile Bay and seining in the salt marshes to gain insight and a better understanding about coastal and ocean issues.

The Teacher of the Year at the secondary level is Mr. Greg Ennis from James Clemens High School in Madison. Greg built the Engineering Academy at James Clemens from the ground up. The Engineering Academy is an area where students begin to practice the skills it takes to be an engineer. As an example, this year Greg secured a wind tunnel to use in aerospace engineering studies. As a result of his efforts, his students have the opportunity work along side mentors at local engineering and aerospace companies, learning first hand what it takes to be an engineer. He also was responsible for creating a program to attract more females into the

engineering discipline. This effort involves having female students participating in the Engineering Academy to visit local middle school to mentor STEM students in hands-on classroom activities.



Tennessee Valley Chapter Support to the United States Space and Rocket Center's Military Emeritus Program

This summer, members of our Chapter actively supported the formation of the United States Space and Rocket Center's (USSRC) Military Emeritus Program by conducting tours of the Aviation Challenge facility. Aviation Challenge has not been generally open to the public, and these new tours have opened the facility and the displayed military aircraft for all to see. Heritage aircraft displays include: an A-12 (the CIA version of the SR-71 Blackbird); an F-4C Phantom that killed a MIG-17 during Operation Bolo during the Vietnam War; an FB-111 "Aardvark" prototype; an F-16B Fighting Falcon dedicated to the Tuskegee Airman of World War II; a MIG-17 "Fresco"; and other Army and Navy aircraft.

The tours also included visits to the aircraft simulators, centrifuge, and barracks. Chapter members who flew some of these aircraft conducted the tours for the Military Emeritus Program and provided insight (there I was war stories!) into the training and life of Air Force pilots and aircrews. The program has been a great success and the USSRC intends to expand public access to Aviation Challenge next year.

Next year's goals for Chapter support to the Military Emeritus Program include: cleaning the F-4C and FB-111; painting the F-4C in Vietnam era camouflage paint; more interaction with Aviation Challenge students and trainees; and expanded tours and public interaction with Aviation Challenge.

AFA—AFCEA Luncheon

Our Chapter, in partnership with the Huntsville chapter of the Armed Forces Communications and Electronics Association (AFCEA), was pleased to present Madison Mayor Troy Trulock as the featured presenter at a joint August luncheon. Mayor Trulock was elected mayor of Madison in 2012 and is a retired Army officer.

Mayor Trulock presented the AFCEA chapter, AFA, and the attendees with an update on the future of Madison, a city adjacent to Huntsville with a reputation for strong schools and persistent academic success. Mayor Trulock discussed a Madison tech startup company with an exciting new technology. RadioBro, a company started by 26 year old twin brothers Mark and Eric Becnel, produces a standard payload interface for small unmanned spacecraft. The RadioBro "mini Satcom" is half the price of competitor offerings and takes an average of 6 months to 2 years off the normal satellite development cycle. Mayor Trulock also discussed the Terabit network backbone that will travel through Madison in the near future, delivering 100 Gigabit network connectivity to Madison businesses.

Mr. Ben McGee, North Alabama ISSA President, also presented and discussed STEM activities in the Madison school system. ISSA and

Huntsville AFCEA partnered to donate several Raspberry Pi computers to the Madison City School 8th grade Cyber program at Discovery Middle. The Raspberry Pi is a single printed circuit board computer the size of a credit card. As a result of the donation, 8th graders were able to install an operating system, configure network connectivity, and finally secure the device. Mr. McGee stressed the importance of hands on learning for today's kids.

At the conclusion of the August Luncheon Jeremy A. Pohly and Breanna M. Crane were presented with AFCEA Huntsville scholarship checks of \$2500 each.



The GATR has been used all over the globe by US Special Operations Forces, USMC Expeditionary Units, select US Army units, Intelligence agencies, elements of the Departments of State and Homeland Security, disaster relief organizations, and foreign allied militaries. GATR SATCOM antennas operate at Ku-, C-, X- and Ka-bands, and transmit all types of data, voice, and video. The ability to hand carry a 2.4m SATCOM terminal changes the way in which humanitarian and relief workers operate in areas like Africa, Haiti, and Afghanistan. Whereas legacy SATCOM antennas required a crane to install them on a rooftop, the GATR can be hand carried via stairs or passenger elevators to the top of the tallest building, and set-up for contingency comms.
